IMPORTANT INFORMATION ABOUT THE PEAK PERIOD



Dear Partner,

In this document, we have gathered all the information you need to know and follow in order to make end of 2024 deliveries a success. Please read it carefully.

- DPD Hungary Kft. will **suspend its time-guaranteed services** (Express 10 and Express 12) **from the**1st of November 2024 until 31 of December 2024.
- Peak surcharge is effective from 1st of November until 31 of December 2024.
- Due to the holidays, the usual Tuesday transfers will be modified as follows:
 - o In the week of Christmas:
 - On 23.12.2024, transfers will be executed for customers with a domestic account number, weekly transfers, daily transfers, Express COD and some ad hoc transfers (transfer notifications will be sent on 30.12.2024).
 - We will execute transfers on 30.12.2024 for customers with a foreign account number, customers with a daily transfer and customers with an Express COD contract (transfer notices will be sent on 02.01.2025).
 - o During the first week of 2025:
 - On 30.12.2024, transfers will be executed for customers with a domestic account number, weekly transfers, daily transfers, Express COD and some ad hoc transfers (transfer notifications will be sent on 02.01.2025).
 - Transfers will be executed on 02/01/2025 for customers with a foreign account number, daily transfers and customers with Express COD (transfer notifications will be sent on 03/01/2025).
 - o From the second week of January 2025 (from 6th of Jan.), transfers will be processed as usual.

Holiday opening hours:

- For domestic parcels picked up by 19 December, we guarantee the first delivery attempt before Christmas.
- As usual, we will attempt to deliver twice during the peak period. After the second unsuccessful
 delivery attempt, parcels will be returned to the depots where the consignee can pick them up
 within 5 working. After 5 days, they will be automatically returned to the sender.
- Our customer service will continue to be available with regular opening hours as follows:
